
Agenda item No.08

1. The Chairman, SLEC has instructed to circulate the file ^{for} remittance for unspent balance of SCP of Rs. 4.10 Crores
2. In Telangana it is proposed for Area Expansion Cocoa in Khammam, Bhadrachalam districts as there is large area under Oil Palm. Further, proposed for subsidy Rs. 20,000/- Ha. (cost Rs. 12/- per plant)
